Subject: Harmonisation with the European Union Directive (EU) 2017/2109:

- 1) The Merchant Shipping (Registration of Persons Sailing on Board Passenger Ships (Amendment) Law of 2020 (Law 188(I)/2020).
- 2) The Reporting Formalities for Ships Arriving in and/or Departing from Ports of the Republic of Cyprus Order of 2020 (P.I. 605/2020).
- 1. I refer to the above subject and wish to inform you of the enactment of the Merchant Shipping (Registration of Persons Sailing on Board Passenger Ships (Amendment) Law of 2020 (Law 188(I)/2020)¹ as well as of the issuing of the Reporting Formalities for Ships Arriving in and/or Departing from Ports of the Republic of Cyprus Order of 2020 (P.I. 605/2020)².
- 2. The purpose of European Union Directive (EU) 2017/2109³, and consequently Law 188(I)/2020 (amending basic Law 57(I)/2002) is to transpose into the Law of the Republic of Cyprus the amendments made to Directive 98/41/EC. The relevant amendments are a result of the implementation of Directive 98/41/EC, which has shown that information on passengers is not always immediately available to the competent authorities when needed, while the current requirements of Directive 98/41/EC should be aligned with the electronic data submission requirements in order to increase efficiency.
- 3. The amendments introduced by Directive (EU) 2017/2109 to Directive 2010/65/EU regarding Part A of the Annex thereof, are introduced to the Cyprus legal order by virtue of the Reporting Formalities for Ships Arriving in and/or Departing from Ports
