Subject: <u>The Safety Zones No. (1) Order of 2014 issued by the Minister of</u> <u>Communications and Works establishing a safety zone within the</u> <u>Exclusive Economic Zone/ Continental shelf of the Republic of Cyprus</u>

1. I refer to the above subject and I wish to inform you of the issuing by the Minister of Communications and Works of the *Safety Zones No. (1) Order of 2014*¹ (Order P.I. 427/2014). Said Order has been issued under the *Safety Zones Regulations of 2013* (P.I. 257/2013) and it establishes a safety zone of 500 metres around the "SAIPEM 1000" platform operating about the geographical point with geographical latitude 33[°] 56' 34" North and geographical longitude 033[°] 42' 08" East².

2. The entry into the aforementioned safety zone by any ship is prohibited unless a ship holds a licence issued by the Ministry of Communications and Works (Regulation 7 of Regulations P.I. 257/2013 is of relevance). Moreover, the **entry into the safety zone** without a licence or in breach of the terms of the licence constitutes a **criminal offence** punishable by a fine up to $\leq 15,000$ (fifteen thousand euro) and/ or imprisonment for a term of 1 (one) year (Regulation 10 of Regulations P.I. 257/2013 is of relevance).

3. Our Department has prepared an unofficial translation of the *Safety Zones No. (1) Order of 2014* in the English language which can be downloaded from the Department's website, selecting "Legislation and Circulars/ Consolidated Cyprus Shipping Legislation/ National Instruments" from the homepage menu.
