The Cyprus Ships (Prohibition of Transportation of Arms and Related Materiel, of Syrian Denominated Banknotes and Coinage, of Crude Oil and Petroleum Products and of Luxury Goods to and from Syria) Order of 2012

I refer to the above matter and further to my Circulars No. 38/2011, No.13/2012, No. 30/2012 and No. 36/2012, I wish to inform you that the Council of Ministers of the Republic of Cyprus, in exercising its powers under section 3 of the Cyprus Ships (Prohibition of Transportation) Laws 1966-1971, issued the Cyprus Ships (Prohibition of Transportation of Arms and Related Materiel, of Syrian Denominated Banknotes and Coinage, of Crude Oil and Petroleum Products and of Luxury Goods to and from Syria) Order of 2012* (Order P.I. 281/2012).

2. Order P.I. 281/2012 reflects and consolidates the recent restrictive measures scheme as prescribed by EU Council Decision 2011/782/CFSP, as amended, as well by EU Council Regulation (EU) no. 36/2012, as amended extensively analysed in our preceding Circulars on the matter (see in particular Circular 30/2012, at the end of paragraph 2, which makes reference to the issuing of a new prohibition Order).

3. All recipients of the present Circular are invited to take note of its content (in addition to the content of previous Circulars on the matter) and should strictly abide by the provisions of Order P.I. 281/2012 and the EU Instruments imposing restrictive measures against Syria.

This Circular must be placed on board vessels flying the Cyprus flag.
