Carrying Capacity

The maximum carrying capacity of powerboats, provided there is fixed for all persons on board, shall be as follows:

Maximum length of vessel (metres)	Total number of persons on board
3	Two (2)
3,5	Three (3)
4	Four (4)
6	Six (6)
8	Seven (7)
10	Eight (8)
15	Twelve (12)

Provided that if a powerboat is constructed in such a way as to be capable of carrying more persons than the number prescribed above, the competent authority may, on the application of the owner of the vessel and following an inspection, prescribe a different maximum carrying capacity than the capacity prescribed above.

The fees for issuing or renewal of the circulation license are given in the table below
