Subject: The Safety Zones No. (2) Order of 2017 and The Safety Zones No. (3) Order of 2017 issued by the Minister of Transport, Communications and Works establishing a safety zone within the Exclusive Economic Zone/ Continental shelf of the Republic of Cyprus

1. I refer to the above subject and I wish to inform you of the issuing by the Minister of Transport, Communications and Works of:

- (i) the *Safety Zones No. (2) Order of 2017* (Order P.I. 425/2017). This Order establishes **as of 15 December 2017** a safety zone of 500 metres around the "SAIPEM 12000" platform operating about the geographical point with geographical latitude 33°30'52".55 North and geographical longitude 31°53'57".26 East;
- (ii) the *Safety Zones No. (3) Order of 2017* (Order P.I. 426/2017). This Order establishes **as of 15 January 2018** a safety zone of 500 metres around the "SAIPEM 12000" platform operating about the geographical point with geographical latitude 34°34'28" North and geographical longitude 34°45'20" East;

2. Said Orders¹ have been issued under the *Safety Zones Regulations of 2013* (P.I. 257/2013). The entry into the aforementioned safety zones by any ship is prohibited unless a ship holds a licence issued by the Ministry of Transport, Communications and Works (Regulation 7 of Regulations P.I. 257/2013 is of relevance). Moreover, the **entry into the safety zones** without a licence or in breach of the terms of the licence constitutes a **criminal offence** punishable by a fine up to €15,000 (fifteen thousand euro) and/ or



imprisonment for a term of 1 (one) year (Regulation 10 of Regulations P.I. 257/2013 is of relevance).

3. Our Department has prepared an unofficial translation of the *Safety Zones No. (2) Order of 2017* and of the *Safety Zones No. (3) Order of 2017* in the English language which can be downloaded from the Department's website, selecting "Legislation and Circulars/ Consolidated Cyprus Shipping Legislation/ National Instruments" from the homepage menu.

4. Our Department may be contacted for any further information with respect to applications for the use/ entry into the safety zones established by virtue of the aforementioned Orders.
