Subject: International Convention on Standards of Training, Certification and Watchkeeping for Seafarers, STCW 78, as Amended- Issue of Seafarer's Identification and Sea Service Record Books and Endorsements Attesting the Recognition of Non Cyprus Certificates

I refer to the above subject and further to our circulars No. 14/2001 dated 29 June 2001 and 26/2001 dated 19/12/2001, I wish to inform that the list of Countries whose certificates of competency are presently recognised by the Republic of Cyprus is as follows:

The Republic of Cyprus, following its accession to the European Union on 1^{st} May 2004, has an obligation to comply with European Directive 2001/25/EC on the minimum level of training of seafarers. Article 18(3) of the abovementioned directive refers to the obligation of a Member State to submit a request for the recognition of a third (non-European) country to the Commission, stating its reasons.

The Commission, assisted by the European Maritime Safety Agency, and with the possible involvement of any member State concerned, will collect all the information referred to in Annex II of the directive and will assess whether the country in question meets all the requirements of the STCW Convention and whether the appropriate measures have been taken to prevent fraud involving certificates. The decision on the recognition of a third country will be taken by the Commission in accordance with the procedure referred to in Article 23(2) of the above mentioned directive, within three months from the date of the request for recognition of the certificates of the Non-European Country.

Cyprus had, in the past recognised the certificates of competency of a number of countries listed on the IMO white list, which, however, were not recognised by the European Commission and issued to holders of such certificates Cyprus endorsements attesting the recognition of their non-Cyprus certificates of competency. In order to avoid causing any inconvenience and injustice to the officers concerned, their Cyprus endorsement certificate will continue to be valid for a period of six months from the date of this circular or until their endorsement is expired, whichever comes earlier.

The Department will be at the disposal of Owners, Managers and anyone concerned with the matter for any explanations and clarifications they may require.
