## Subject: Implementation of EU Harmonising Legislation: The Merchant Shipping(Safe Manning, Hours of Work and Watchkeeping) (Amendment) Law of 2004 (Law 162(I) /2004).

**1.** I wish to inform you that the *Merchant Shipping(Safe Manning, Hours of Work and Watchkeeping) (Amendment) Law of 2004 (Law 162(I) /2004)* was enacted for the purpose of the better transposition into our national legislation of Directive 2001/25/EC of the European Parliament and of the Council of 4<sup>th</sup> April 2001, on the minimum level of training of seafarers.

**2.** The above mentioned law entered into force on the <u>1<sup>st</sup> of May 2004</u>.(date of accession of the Republic of Cyprus to the EU).

The purpose of Law 162(I)/2004 is the harmonisation with articles 17(a-e), 20(1-3) and 21(a) and (e) of Directive 2001/25/EC and the introduction of provisions regarding the common language or working language on board the ship, Port State Control procedures and grounds for detention.

Law 162(I)/2004 amends sections 2,14 and 36 of the Merchant Shipping (*Safe Manning, Hours of Work and Watchkeeping*) Law of 2000 (Law 105 (I) /2000).

**3.** Further details and requirements with regard to the effective implementation of the harmonising legislation will be communicated to you by a new Circular to be issued in the near future.
