**Subject: Directory of Services and Contact Persons of the Department of Merchant Shipping**

As a result of extensive changes in the personnel and the organization of the Department, a new Directory of Services and Contact Persons has been issued, incorporating the changes which have been effected to date.

The new Directory incorporates Emergency Contacts which may be used to transmit information to the Department regarding casualties and security alerts as well as contacts for after office hours emergency support services.

The following points should be observed for the effective utilization of the electronic addresses:

1. Each division and specialized section of the Department has been allocated a specific e-mail address. All correspondence related to the activities of these divisions or sections which may be transmitted electronically, should be addressed to these divisions' or sections' e-mail addresses. Personal e-mail addresses should only be used for direct reply to messages sent from these addresses and in cases where the message follows an oral communication with the officer concerned. This is necessary in order to avoid a delay in the receipt and processing of the messages by the Department, in case the officer is on leave or on an official duty abroad.
2. Any correspondence which is non routine or is not specific to a particular division or touches upon issues of general policy of the Department, should be addressed to [maritimeadmin@dms.mcw.gov.cy](mailto:maritimeadmin@dms.mcw.gov.cy) or to [director@dms.mcw.gov.cy](mailto:director@dms.mcw.gov.cy).
3. Formal correspondence, applications for registry transactions and any other documents required for the processing of applications, should also be submitted in original, hard copy form.



4. As a general rule, classified or confidential correspondence should not be transmitted electronically. If the need arises to transmit an urgent message with a certain degree of confidentiality, it should be addressed to [director@dms.mcw.gov.cy](mailto:director@dms.mcw.gov.cy).
