**Subject: Port State control – 2011 Concentrated Inspection Campaigns**

I wish to inform you that the Paris, Tokyo, Black Sea, Vina del Mar and Mediterranean Memoranda of Understanding on port State control (MoUs) will be carrying out a joint Concentrated Inspection Campaign (CIC) between 1 September 2011 and 30 November 2011.

2 The CIC will be addressing Structural Safety and the International Load Line Convention (ILLC). During the CIC, port State control officers (pScos) will be focusing their attention to the relevant shipboard documentation and will be conducting detailed inspections of the various items covered by the ILLC. 3 Ships entitled to fly the Cyprus flag should expect visits by pScos whilst in ports, roadsteads, anchorages and offshore terminals located within the territory or under the jurisdiction of the States which are parties to the Paris, Tokyo, Black Sea, Vina del Mar and Mediterranean MoUs.

4 Ships, irrespective of the flag they may be entitled to fly, calling at ports and anchorages in Cyprus will be inspected by the pScos of the Department.



5 As during previous CICs, the Paris, Tokyo, Black Sea, Vina del Mar and Mediterranean MoUs will continue to conduct port State control inspections of all ships in accordance with their established programs.
