Subject: The Merchant Shipping (Issue and Recognition of Certificates and Marine Training) (Amendment) Law of 2017, (Law 10(I)\2017) - Implementation of relevant EU Legislation and of the STCW Convention as amended

- 1. I refer to the above subject and further to our Circular No.16/2008 dated 2 September 2008, I wish to inform you of the recent enactment of the Merchant Shipping (Issue and Recognition of Certificates and Marine Training) (Amendment) Law (Law 10(I)/2017) published in the Official Gazette of the Republic No.4589, Supplement I (I), dated 17.2.2017, amending the relevant basic Law of 2008, namely the Merchant Shipping (Issue and Recognition of Certificates and Marine Training) Law of 2008 (Law 27(I)/2008)
- **2.** Amendment Law 10(I)/2017 amends the basic Law 27(I)/2008 and aims at:
 - i) The transposition into our national legislation part of the provisions of *Directive* 2012/35/EU of the European Parliament and of the Council of 21st November 2012, amending Directive 2008/106/EC on the minimum level of training of seafarers. It should be noted that the great majority of the provisions of *Directive* 2012/35/EU has already been transposed into our national legislation.

- ii) The effective implementation of the STCW Convention as amended by virtue of the 2010 Manilla Amendments (relevant is our Circular No. 34/2016 dated 21 November 2016).
- **3.** Furthermore, Amendment Law 10(I)/2017 provides for the following new Certificates:
 - Certificate of Competency of Master for vessels with tonnage up to 500,
 - Certificate of Competency of Chief Engineer for vessels with propulsion power up to 750 Kw.
 - Certificate of Competency of Electro-Technical Officer.
 - Certificate of proficiency for Able Seafarer Deck



- Certificate of proficiency for Able Seafarer Engine
- Certificate of Proficiency for Electro-Technical Rating
