**Subject: The Safety Zones No. (2) Order of 2014 issued by the Minister of Communications and Works establishing a safety zone within the Exclusive Economic Zone/ Continental shelf of the Republic of Cyprus- Corrigendum**

1. I refer to the above subject and further to my Circular No. 45/2014 dated 22 December 2014. I wish to inform you that with regard to the *Safety Zones No. (2) Order of 2014* (Order P.I. 574/2014)<sup>1</sup> a necessary corrigendum has been published today in the Official Gazette of the Republic of Cyprus (Gazette no 4842, dated 31/12/2014, page 3274).

2. The said Corrigendum relates to the geographical coordinates stated in subparagraph (1) of paragraph 3 of Order P.I. 574/2014 so that the current geographical point with geographical latitude 33° 44' 18" North and geographical longitude 033° 19' 33" East<sup>2</sup>, is replaced with a reference to the geographical latitude **33° 50' 34.8" North** and geographical longitude **033° 18' 51.8" East**.

Therefore, the relevant safety zone of 500 metres established around the "SAIPEM 1000" platform is for operating about the geographical point with geographical latitude **33° 50' 34.8" North** and geographical longitude **033° 18' 51.8" East**.

3. As a result of the above mentioned Corrigendum, the corresponding wording of subparagraph (1) of paragraph 3 of the unofficial translation of the *Safety Zones No. (2) Order of 2014* in the English language,<sup>3</sup> has been corrected-amended accordingly.
