Subject: New Prohibition Orders (PI) issued with respect to restrictive measures against Ivory Coast, Somalia, Central African Republic, Yemen and South Sudan

- 1. I refer to the above subject and I wish to inform you that the Council of Ministers of the Republic of Cyprus, in exercising its powers under section 3 of the Cyprus Ships (Prohibition of Transportation) Laws 1966-1971, issued the following Prohibition Orders¹:
 - The Cyprus Ships (Prohibition of Transportation of Arms and Related Materiel to certain Persons or Entities in Yemen) Order of 2015, <u>P.I. 426/2015</u>, the measures of which have been described in DMS Circular No. 19/2015;
 - (ii) The Cyprus Ships (Prohibition of Transportation of Arms and Related Materiel to Somalia) Order of 2015, <u>P.I. 427/2015</u>, the measures of which have been described in DMS Circular No. 22/2015;
 - (iii) The Cyprus Ships (Prohibition of Transportation of Arms and Related Materiel to the Central African Republic) Order of 2015, <u>P.I. 428/2015</u>, the measures of which have been described in DMS Circular No. 18/2015;
 - (iv) The Cyprus Ships (Prohibition of Transportation of Arms and Related Materiel to South Sudan) Order of 2015, P.I. 429/2015, the measures of which have been described in DMS Circular No. 16/2015:



This Circular must be placed on board vessels flying the Cyprus flag.
