## Subject: <u>Concentrated Inspection Campaign (CIC) on Crew Familiarization</u> for Enclosed Space Entry

I would like to inform you that the Maritime Authorities of Paris MOU, Tokyo MOU and Mediterranean MoU will carry out a Concentrated Inspection Campaign (CIC) on Crew Familiarization for Enclosed Space Entry. The aim of the CIC is to ensure effective procedures and measures are in place to safeguard seafarers on board ships when entering and working in enclosed spaces and to check compliance with the applicable requirements of the SOLAS Convention.

2. The Campaign will be conducted for a period of three months, commencing from 1<sup>st</sup> September 2015 to 30<sup>th</sup> November 2015. During the CIC, port State control officers will check in detail the ship's procedures and measures that are in place with respect to enclosed spaces.

3. Port State Control Officers (PSCOs) of the Maritime Authorities of Paris MOU and Tokyo MOU will use a list of 10 questions (shown in Annex 1) in order to establish that crew members with enclosed space duties are familiar with relevant equipment and have received training to carry out their duties and identify and understand the hazards associated with entry into enclosed spaces.

4. Owners and managers are urged to take all appropriate actions in order to ensure that crew members on board ships flying the Cyprus Flag with enclosed space duties are familiar with relevant equipment and have received training to carry out their duties and identify and understand the hazards associated with entry into enclosed spaces.

5. It should be noted that undergoing a CIC inspection in one of the MOU's will not prevent PSCO of another MOU to execute the CIC inspection again for his / hers own region.



6. Additionally I wish to inform you that on the public sector of the Paris MOU web site (www.parismou.org) you may find important information regarding the port state control (PSC) procedures for the Paris MOU region. Under the tab "Publications" you will find a tab labeled "PSC inspection guidelines" which will assist you to prepare for PSC inspections in the Paris MOU region specifically but also worldwide in general. It is advised that you regularly visit the Paris MOU web site to keep update with the changes occur in the PSC regime.

Q.9 *	During the CIC, the PSCO is to observe an enclosed space entry and rescue drill. Did the drill comply with the requirements of SOLAS Chapter III, Regulation 19.3.6?			
Q.10	Is the ship detained as a result of a "NO" answer to any of the questions?

Note 2 Each question should be answered and only one box ticked for that question.

Note 3 Questions with an asterisk indicate Code 30 may be issued.
