To all Owners, Managers and Representatives of Ships under the Cyprus Flag.

Subject: Implementation of EU Harmonising Legislation: The Merchant Shipping (Port State Control) Laws of 2001 - 2004: Adoption of The Merchant Shipping (Port State Control) First Notification of 2005 / English version available on the DMS Website

- 1. I refer to the above subject and further to my previous Circulars No. 15/2004, No. 55/2004, No. 9/2005 and No. 27/2005, I am pleased to inform you that pursuant to the provisions of the *Merchant Shipping (Port State Control) Laws of 2001 and 2004 (Law 47(I)/2001 as amended by Law 27(I) of 2004)*, *The Merchant Shipping (Port State Control) First Notification of 2005 (P.I.256/2005)* was issued under my hand and published in Greek in the Official Gazette of the Republic No. 3994, Supplement III (I), dated 20 May 2005.
- **2.** Therefore, since 20 May 2005, port State control of foreign vessels in the ports of the Republic is conducted according to the provisions of this *First Notification of 2005*. Actually, *P.I.* 256/2005 incorporates into the Cyprus legal order the detailed requirements contained in the twelve Annexes of EU Directive 95/21/EC of 19 June 1995 on Port State Control as amended¹.

P.I.256/2005 contains *twelve Schedules*, each one reflecting the twelve Annexes of the said EU Directive in the following manner:

First Schedule: Corresponds to Annex I of the Directive.

Second Schedule: Corresponds to Annex II of the Directive.

Third Schedule: Corresponds to Annex IV of the Directive.

Fourth Schedule: Corresponds to Annex V of the Directive.

Fifth Schedule: Corresponds to Annex XI of the Directive.

Sixth Schedule: Corresponds to Annex III of the Directive.

Seventh Schedule: Corresponds to Annex IX of the Directive.

Eighth Schedule: Corresponds to Annex VI of the Directive.

Ninth Schedule: Corresponds to Annex XII of the Directive. Tenth Schedule: Corresponds to Annex VII of the Directive. Eleventh Schedule: Corresponds to Annex VIII of the Directive. Twelfth Schedule: Corresponds to Annex X of the Directive.
