<u>Subject: Bilateral Agreements on Merchant Shipping between the Government of</u> the Republic of Cyprus and the Governments of other countries.

I wish to refer to the above subject and to inform you that the following Agreements on Merchant Shipping have recently been concluded between the Government of the Republic of Cyprus and the Governments of other countries.

- **1.** Agreement between the Government of the Republic of Cyprus and the Government of Antigua and Barbuda on Merchant Shipping, signed in New York on 9th June 2006. (Published in the Official Gazette No.4075, Supplement VII, dated 10.11.2006).
- **2.** Agreement between the Government of the Republic of Cyprus and the Government of Romania on Maritime Transport, signed in Nicosia on 23rd October 2006. (Published in the Official Gazette No.4077, Supplement VII, dated 10.1.2007). This Agreement will substitute a previous Agreement concluded between the two countries on 25.10.1983.
- **3.** Agreement between the Government of the Republic of Cyprus and the Government of the Republic of the Philippines on Merchant Shipping, signed in Nicosia on 9th November 2006. (Published in the Official Gazette No.4077, Supplement VII, dated 10.1.2007). This Agreement will substitute a previous Agreement concluded between the two countries on 7.9.1984.
- **4.** Agreement between the Government of the Republic of Cyprus and the Government of the Arab Republic of Egypt on Merchant Shipping, signed in Cairo on 26th November 2006. (Published in the Official Gazette No.4076, Supplement VII, dated 20.12.2006).
