Subject: New UN and EU instruments on restrictive measures against the Ivory Coast: Lifting of the arms embargo.

1. I refer to the above subject and I wish to inform you of the recent adoption by the United Nations and European Union of the following instruments concerning restrictive measures against the Ivory Coast:
 - a. ***United Nations Security Council Resolution (UNSCR) 2283 (2016);***
 - b. ***EU Council Decision (CFSP) 2016/917 of 9th June 2016 repealing EU Council Decision 2010/656/CFSP;***
 - c. ***Council Regulation (EU) 2016/907 of 9th June 2016 repealing Regulation (EC) No 174/2005 imposing restrictions on the supply of assistance related to military activities to Côte d'Ivoire and Regulation (EC) No 560/2005 imposing certain specific restrictive measures directed against certain persons and entities in view of the situation in Côte d'Ivoire.***
2. The impact of the aforesaid instruments is the lifting of the arms embargo. As a result our Department has proceeded with the drafting of a repealing Order, which seeks to repeal existing Prohibition Orders P.I. 509/2014 and P.I. 430/2015.
3. This Circular repeals previously issued DMS Circulars No. 21/2015, No. 28/2014 and No. 38/2014.

5. All recipients of the present Circular are invited to take note of its content.

This Circular must be placed on board vessels flying the Cyprus flag.
