### SANCTIONS INFORMATION NOTICE

To all Registered owners, Registered bareboat charterers  
Managers and Representatives of ships flying the Cyprus Flag

**Subject: New UN and EU restrictive measures in view of the situation in Libya –  
Update on the listing of vessels “Nadine (previously named Capricorn)”  
(IMO No. 8900878) and “Lynn S” (IMO No. 8706349)**

I refer to the above matter and further to SIN. No. 11/2017 and SIN. No. 12/2017 I wish to  
inform you as follows:

1. The United Nations Security Council Committee established pursuant to United Nations Security Council Resolution 1970 (2011) has recently renewed and amended the status of the listing of vessels “Nadine (previously named Capricorn)” (IMO No. 8900878) and “Lynn S” (IMO No. 8706349), actions subsequently implemented by the Council of the European Union. The status of the designation of the afore mentioned vessels is as follows:

- (A) Name of Vessel: **NADINE** (previously named **CAPRICORN**)  
Flag: **PALAU**  
Imo No. **8900878**  
Last seen: As of 19 January 2018 the vessel was located near the coast of Muscat, Oman outside its territorial waters.

Designation is valid until **17<sup>th</sup> April 2018**

The renewal and amendment of the aforesaid designation was implemented by the European Union by virtue of:



- **Council Implementing Decision (CFSP) 2018/132** amending Annex V of **Decision (CFSP) 2015/1333** as amended;
- **Commission Implementing Regulation (EU) 2018/126** amending Annex V of **Regulation (EU) 2016/44** as amended;
- **Council Implementing Decision (CFSP) 2018/203** amending Annex V of **Decision (CFSP) 2015/1333** as amended;
- **Commission Implementing Regulation (EU) 2018/200** amending Annex V of **Regulation (EU) 2016/44** as amended.

(B) Name of Vessel: **LYNN S**  
 Flag: **Saint Vincent and the Grenadines**  
 Imo No. **8706349**  
 Last seen: As of 6 October 2017 the vessel was located in the territorial waters of Lebanon, when it set sail heading West.

Designation is valid until **28<sup>th</sup> April 2018**

The renewal and amendment of the aforesaid designation was implemented by the European Union by virtue of:

- **Council Implementing Decision (CFSP) 2018/167** amending Annex V of **Decision (CFSP) 2015/1333** as amended;
- **Commission Implementing Regulation (EU) 2018/166** amending Annex V of **Regulation (EU) 2016/44** as amended.

2. It is recalled that the aforesaid designated vessels contained in Annex V of Regulation (EU) 2016/44 as amended and of Decision (CFSP) 2015/1333 as amended, are **prohibited** from **loading, transporting or discharging crude oil** from Libya, to **access ports** in the territory of the European Union, and to be provided with **bunkering or ship supply services**.

It is recalled that the House of Representatives of the Republic of Cyprus, has enacted in April 2016 the *Implementation of the Provisions of the United Nations Security Council Resolutions or Decisions (Sanctions) and the European Union Council Decisions and Regulations (Restrictive Measures) Law of 2016 (Law 58(I)/2016)*.<sup>1</sup> The purpose of Law 58(I)/2016 is to set out the obligations of any person or entity in the Republic of Cyprus to abide and comply with all the provisions of the UNSCRs and /or the relevant EU Decisions and Regulations. Under this Law all UN and EU instruments are incorporated and adopted into the national legal order without the need of enacting Prohibition Orders (as was the practice in the past years), and are thus automatically applicable and binding.

5. All recipients of the present Sanctions Information Notice are invited to take note of its content and should strictly abide by the provisions of the relevant EU Instruments and the DMS Circulars and Sanctions Information Notices.

**This Sanctions Information Notice must be placed on board vessels flying the Cyprus flag.**
