To all Registered owners, Registered bareboat charterers Managers and Representatives of ships flying the Cyprus Flag

Subject: New Prohibition Orders (PI) issued with respect to restrictive measures against the Central African Republic, Democratic People's Republic of Korea and Libya

- 1. I refer to the above subject and I wish to inform you that the Council of Ministers of the Republic of Cyprus, in exercising its powers under section 3 of the Cyprus Ships (Prohibition of Transportation) Laws 1966-1971, issued the following three Prohibition Orders¹:
 - (i) The Cyprus Ships (Prohibition of Transportation of Arms and Related Materiel to the Central African Republic) (Amendment) Order of 2016, <u>P.I. 227/2016</u>, implementing the relevant UN and EU economic sanctions the measures of which have been described in DMS Circular No. 12/2016;
 - (ii) The Cyprus Ships (Prohibition of Transportation of Arms, Related Materiel, Bank Notes, Coinage, Luxury Goods and other cargo to the Democratic People's Republic of Korea) Order of 2016, P.I. 228/2016, implementing the relevant UN and EU economic sanctions the measures of which have been described in DMS Circular No. 11/2016; and
 - (iii) The Cyprus Ships (Prohibition of Transportation of Arms and Related Materiel to Libya) Order of 2016, P.I. 229/2016, implementing the relevant EU economic sanctions the measures of which have been described in DMS Circular No. 9/2016.
- 2. All recipients of the present Circular are invited to take note of its content and should strictly abide by the provisions of the aforementioned Prohibition Orders, DMS Circulars as well as the UN & EU Instruments implemented by virtue thereof.

This Circular must be placed on board vessels flying the Cyprus flag.
