To all Owners, Managers and Representatives of Ships under the Cyprus Flag

Subject: <u>Certificates of Competency and Training Documentary Evidence Issued by the</u> <u>Government of the Philippines</u>

With respect to the above subject, the competent Authorities of the Philippines have informed us, as per attached letter dated 6^{th} September 2005, that the STCW 78 as amended certificates, including certificates and training documentary evidence required under Chapters V and VI of the STCW 78 convention as amended, which are held by Filipino seafarers, are valid only if they have been issued by the competent authorities of the Philippines.

Therefore, all Owners and Managers are advised, whenever they intend to employ Filipino crew on board their Cyprus flagged vessels, to check their certificates and training documentary evidence whether they have been issued by the competent Authorities of the Philippines, before the Filipino seafarers sign on. If a certificate or training documentary evidence is not issued by the competent Authorities of the Philippines or by any other State whose certificates are recognised by Cyprus, the holder of such document should be advised to apply for a proper Filipino certificate.

The Department will be at the disposal of Owners, Managers and anyone concerned with the matter for any explanations and clarifications they may require.
