Subject: <u>New Cyprus Tonnage Tax Legislation: The Merchant Shipping</u> (Fees and Taxing Provisions) Law of 2010 (Law 44(I)/2010) - The Tonnage Tax (Special Provisions for the Calculation of the Community Flagged Share) Notification of 2010 (P.I. 536/2010)

I refer to the above subject and further to my Circulars No. 14/2010, 28/2010, 32/2010, 39/2010 and 42/2010 respectively, I wish to inform you that the following implementing sixth Notification provided under the above Law, has been issued and published in the Official Gazette on 31 December 2010, namely:

The Tonnage Tax (Special Provisions for the Calculation of the Community Flagged Share) Notification of 2010 (P.I. 536/2010), issued by virtue of sections 15(2), 15(3)(b), 25(2)(c), 25(3)(b), 35(1)(b) and 35 (2)(b) of Law No. 44(I)/2010.

The said new Notification applies to any qualifying owner of a fleet of ships comprising Community and non-Community ships, or any qualifying charterer of a fleet of ships comprising Community and non-Community ships, or any qualifying ship manager.

Under the same icon, you may also find an <u>updated INDEX</u> of all the Notifications already issued, or to be issued under Law 44(I)/2010 (seven Notifications in total have to be adopted).

Further details as to the issuance and publication in the Official Gazette of the <u>remaining</u> seventh Notification on ring-fencing matters provided under the said Law, will be given in a new Circular in the coming weeks.
