Subject: Continuous Synopsis Record (CSR) for Cyprus flag vessels

ANNEX

1) Applications for the issue / changes / issue of a missing CSR document and ISPS C1, C2 and C3 forms submitted to the Department of Merchant Shipping.

The Department of Merchant Shipping accepts applications and forms from:

- The Owner of the vessel;
- The Management Company of the vessel;
- An authorised representative of the owner or management company, provided that the name and contact details have been communicated to the Department by either the Owner or the Manager of the vessel prior to the submission of the forms / applications.

Above mentioned applications will be accepted provided that the Owner's and Manager's IMO Identification numbers have also been communicated with the application / forms. The Department of Merchant Shipping will issue and forward to the applicant the requested documents provided that the appropriate fees have been paid to the Department. The applicants must inform the Department the address where the CSR documents should be dispatched.

2) Continuous Synopsis Record – when ships are deleted from the Register of Cyprus Ships

When an application for the deletion of a ship from the Register of Cyprus Ships is submitted to the Registrar of Ships, the owners / managers / authorized representatives must communicate in writing the name of the new flag State of the ship in order to expedite the issuance of the closed CSR (which includes the deletion details from this Administration).

When a ship is deleted from the Register of Cyprus Ships, and the original CSR or CSRs issued by the Department of Merchant Shipping are not on board, all missing CSR documents will be re-issued provided that:

- A written request has been submitted to the Department of Merchant Shipping (Maritime Security Section) by the new owner / manager providing sufficient reasons for their request.
- The new owner/manager must take care of the payment of the relevant fees and either appoint a representative and advise the Maritime Security Section of his name to collect the documents or give the address where these should be dispatched.
- Remittances of fees for the issue or re-issue or re-issue of CSR documents, as well as of
 postages and Bank charges should be made to the name of THE DIRECTOR
